The Blairsville Municipal Authority (PWS ID#5320006) is pleased to present to you this year's Consumer Confidence Report. This Report, required by the 1996 amendments to the Safe Drinking Water Act, is designed to inform you about the water quality and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water.

We have a source water assessment report available at our office that provides more detailed information such as potential sources of contamination. A summary of our water system's susceptibility to potential sources of contamination follows:

A Source Water Assessment of the Trout Run Reservoir and the land area that provides groundwater, which supplies water to the Treatment Plant, was completed in 2003 by the PA Department of Environmental Protection (PADEP). The Assessment has found that the assessment area is potentially most susceptible to accidental spills along roads, aerial spraying near telephone lines and erosion from ATV use. Complete reports were distributed to municipalities, water supplier, local planning agencies and PADEP offices. The Authority wants its customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the fourth Wednesday of each month at 7:00 p.m. at the Blairsville Municipal Building.

Our raw water is withdrawn from four different sources: the Trout Run Reservoir, two wells that are located near the Trout Run Reservoir and a third well situated near Bear

Run and Township Road T-972. All of our water sources are located in Derry Township, Westmoreland County.

The Blairsville Municipal Authority routinely monitors for constituents in your drinking water according to Federal and State laws. This report shows the results of the monitoring for the period of January 1 to December 31, 2014. As you can see by the data table, our system had no violations for water quality. We're proud that your drinking water meets or exceeds all Federal and State requirements. The state and EPA require us to test our water on a regular basis to ensure its safety. It should be noted that the Authority failed to submit a sample of haloacetic acids and trihalomethanes at one of its sampling sites in the fourth quarter of 2013. As a result, it triggered a violation for the 2014 Operating Year. However, all other samples indicate that the water is safe to drink. We are reviewing our procedures to ensure that this paperwork will be submitted in a timely manner in the future.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity.

Contaminants that may be present in source water before it is treated include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration and EPA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Information About Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Authority is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. (a) Turbidity is a measure of the cloudiness of the water. We monitor turbidity because it is a good indicator of the effectiveness of our filtration system.

Terms and abbreviations used above:

- i **Parts per million (ppm)** – Parts per million/milligrams per liter.
- i **Parts per billion (ppb)** – Parts per billion/micrograms per liter.
- i **Nephelometric Turbidity Unit (NTU)** – A measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.
- i **Not Applicable (N/A)**
- i **Action Level (AL)** – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- i **Treatment Technique (TT)** – A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.
- i **Maximum Contaminant Level (MCL)** – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- i **Maximum Contaminant Level Goal (MCLG)** – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- i **Maximum Residual Disinfectant Level (MRDL)** – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

i **Maximum Residual Disinfectant Level Goal (MRDLG)** – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefit of the use of disinfectants to control microbial contamination.

i **Minimum Residual Disinfectant Level (Min RDL)** – The minimum level of residual disinfectant required at the entry point to the distribution system.

Your Toilet Could Be Leaking Without Your Knowledge

A small leak can be almost silent and go relatively unnoticed. However, even a small, silent leak can waste over 200 gallons of water per day.

Remove the cover of the tank of your toilet. Place about 6-10 drops of food dye in the tank. DO NOT FLUSH THE TOILET. Check the toilet bowl in about 15 minutes to see if any color has leaked through. If there is now food dye in the bowl of your toilet, you have a leaking toilet tank. If you discovered your toilet tank is leaking, get it fixed as soon as possible. Even a small leak wastes a lot of water.

Water Conservation

Here are some conservation tips for saving water. Never use your toilet as a wastebasket, take shorter showers or take a shallow bath instead of a shower. Turn off the tap while brushing your teeth or shaving, while waiting for hot water from the tap, catch the flow in a watering can and use it for watering house or garden plants. Keep a bottle of tap water in the refrigerator instead of running the faucet for cold water. Wash vegetables and fruit in a basin. Run the dishwasher and washing machine only when full. By following these tips, you can save hundreds of gallons of water a day.
